EFFECTIVE MARCH 1, 2021
City of Loveland Water and Power - Water Metering will begin assessing return trip fees as follows:
<ul style="list-style-type: none"> • Scheduled water meter sets that do not result in a meter "set" due to Contractor's failure to adhere to requirements. • Scheduled final water meter inspections that do not result in an approved status AFTER the second failed inspection.
Return trip fees will be assessed on all active permits regardless of issuance date. Once assessed, these fees are required to be paid before any other inspection may be called on the building permit.
The 2024 return trip fee is \$85. This fee is subject to change. For current fees, please reference the Water and Power Department Schedule of Rates, Charges, and Fees, available on-line.

Important Note: The City of Loveland Water Metering Group will not set a water meter unless water to the building may be activated. When requesting a water meter set, the caller must state that the valve inside the building is off and the system is ready for water to be turned on. *(Please be aware of weather conditions when scheduling a water meter set; for instance, is there heat in the building to avoid freezing pipes?)* Water Metering employees are not authorized to inspect or otherwise check plumbing on the inside of a building. Jumpers are not allowed to be installed in pits.
