

AMENDMENT TO THIRD-PARTY REIMBURSEMENT AGREEMENT
Wastewater Major Structure Improvements

This Amendment to Third-Party Reimbursement Agreement (“Amendment”) is entered into by and between the **City of Loveland, Colorado**, a home rule municipality (“**City**”), and the **City of Loveland Water Department (“Developer”)**. This Amendment is effective as of the date of the City’s execution in the City’s signature block below.

Whereas, the City and Developer are parties to a Third-Party Reimbursement Agreement dated September 7, 2004 (“Original Third-Party Reimbursement Agreement”) and recorded on 12/21/2004 as REC #2004-0121964 and known as the **East Side Lift Station** to provide for the installation of certain wastewater improvements in order to facilitate development of certain lands that will benefit from such improvements, located in the: SE quarter of Section 17, NW quarter of Section 16, and SW quarter of Section 16, Township 5 North, Range 68 West of the 6th P.M., City of Loveland, County of Larimer, State of Colorado; and

Whereas, the City’s policy regarding extension and oversizing of public water and wastewater improvements, and reimbursement for said extension and oversizing, is set forth in Title 13 of the Loveland Municipal Code; and

Whereas, in 2014, the City adopted section 13.08.150.D of the Loveland Municipal Code, which provides as follows:

When the city constructs a lift station at the city's expense, the city may require property owners within the lift station service area to pay a portion of the cost of the lift station. The reimbursement amount shall be determined on a cost per developable area to be served by the lift station, as determined by the director of the water and power department. The reimbursement amount shall be due and paid prior to connection to the city's wastewater system. No building permit for property subject to the payment requirement set forth herein shall be issued until the reimbursement amount is paid. The reimbursement obligation shall remain in effect and shall be enforceable as long as the lift station is in service. The city shall record with the Larimer County Clerk and Recorder a notice of the encumbrance and reimbursement amount due for each encumbered property.

Whereas, the original Third-Party Reimbursement Agreement provides for a specific term of effectiveness; and

Whereas, consistent with section 13.08.150.C of the Loveland Municipal Code, the City and Developer desire to amend the original Third-Party Reimbursement Agreement to extend the reimbursement obligation date to remain in effect and to be enforceable as long as the water and wastewater system improvements are in service, or until the maximum reimbursement is made, whichever date is earlier.

Now, therefore, in consideration of the mutual covenants and agreements contained herein, the parties agree as follows:

1. **Term.** The term of the original Third-Party Reimbursement Agreement is hereby extended and shall remain in effect as long as the Lift Station remains in service, or until the

maximum reimbursement is made, whichever date is earlier.

2. **Recording.** The Developer shall record this Agreement with the Larimer County Clerk and Recorder and shall solely be responsible for all associated costs.

3. **Notice.** Within 90 days of the recording of this Amendment, a Notice of this Amendment shall be mailed by regular US Mail to the record owner of all properties that remain subject to the Reimbursement Agreement.

4. **Electronic Signature.** This Agreement may be executed by electronic signature in accordance with C.R.S § 24-71.3-101 *et seq.*

5. All other terms and conditions of the original Third-Party Reimbursement Agreement shall remain in full force and effect according to the provisions thereof.
