#### Discussion:

**Bill Szmyd** wanted to know what happens if the Council 'balks' and thinks the request for the 2025 budget is too high. **Jim Lees** acknowledged that could be a risk, but the majority of our budget requests are regulatory-driven and are necessary. **Kevin Gertig** acknowledged that we need to increase our messaging to the citizens to show them how essential these capital investments are. If we need to cut items, we will need to make a risk assessment and determine what projects we cut or scale back.

**Jim Lees** clarified that the 6% increase suggested for the Power utility equates to an approximately \$7 per month increase on an average bill to our customers.

Council has made two attempts at getting a sales tax increase approved that have been unsuccessful. Council continues to look at potential budget cuts. Most of the Council's perspective is to preserve public safety, roads, and other items deemed essential, but that means that those 'added services' (like the library, museum, and parks) are taking the hit. Councilor Olson is convinced that if the citizens don't experience the loss, they will not agree to a tax increase. He anticipates that the Mayor and some members of council will use the City's reserve funds to meet the 2024 shortfall, which prohibits the city from being able to immediately fund an emergency. Olson also gave a brief update on the homeless issue in Loveland.
