Hydrozone Participant Exemption Request Form

The exemption request form allows Hydrozone Program participants undergoing landscape replacement or redesign to apply for a one-year exemption period from certain surcharges and/or water rights payments. This exemption, if approved by the director, exempts a participant from the surcharge and does not count towards the three consecutive years that could trigger full water rights payment. To apply, Hydrozone Program participant must submit a detailed description of the proposed landscape changes, receipts for soil amendments and/or new plantings, and supporting evidence such as photographs. The redesigned landscape's irrigation must stay within the original annual water budget to avoid additional water rights payments. It is required the exemption request is submitted before July 1 of the year in which the landscape replacement or redesign will occur.

Municipal Code: 19.06.050 - Irrigation subject to Hydrozone water budget, Subsection G.2.

Additional Details

- Upon submitting a completed application, allow adequate time for staff to fully review the application. Additional information may be requested from the applicant.
- Once the exemption is approved or denied, a letter will be emailed to the applicant indicating the status.
- Please understand that clear and detailed application information will enable staff to provide more detailed comprehension of circumstances and exemption eligibility.

 - d. Other extrinsic evidence that justifies a one-year exemption
